NOAA Fisheries Requests Comments on Actions Affecting Headboat Vessels Fishing for Snapper-Grouper, Coastal Migratory Pelagics, and Dolphin-Wahoo in the South Atlantic (Comment Period Ends November 18, 2013)

NOAA Fisheries requests comments on the For-Hire Reporting Amendment, which includes:

- Amendment 31 to the Fishery Management Plan for the Snapper-Grouper Fishery of the South Atlantic Region;
- Amendment 6 for the Dolphin and Wahoo Fishery of the Atlantic; and
- Amendment 22 for the Coastal Migratory Pelagic Resources in the Atlantic and the Gulf of Mexico.

The Notice of Availability for the For-Hire Amendment published in the *Federal Register* on September 18, 2013 (78 FR 57339).

If approved, the For-Hire Reporting Amendment would require headboat vessels fishing in the South Atlantic for snapper-grouper, dolphin and wahoo, and coastal migratory pelagics to submit weekly electronic fishing records to the Southeast Fisheries Science Center Science and Research Director, or at intervals shorter than a week if notified by the Science and Research Director.

Request for Comments

Comments on the For-Hire Amendment must be received no later than **November 18, 2013**, to be considered by NOAA Fisheries. See the Addresses section for information on where and how to submit comments.
