All requests must provide the information listed below to attain a catch history. This form or a hand written request is acceptable. All catch records are logged by vessel, not by permit. Catch data is considered confidential under the Magnuson-Stevens Act therefore only the owner of the permit at the time of catch may access those catch records. Catch history requests are for the release of confidential catch information only.

Catch histories are available ONLY to the owner of the vessel at the time of the catch to whom the permits were issued, or if the vessel was leased, the lessee of the vessel at the time of catch to whom the permits were issued.
