2 Stated vessel trip limits are effective unless an in-season trip-limit reduction or fishery closure has been implemented.

3 The Florida east coast subzone, located between the Flagler/Volusia and the Miami-Dade/Monroe County boundaries, exists only from November 1 through March 31, when Gulf group king mackerel extend into that area. From April 1 through October 31, king mackerel landed in this area belong to the Atlantic migratory group of king mackerel.

4 Trip limit increases from 50 fish/day to 75 fish/day on February 1 if less than 75% of the subzone's quota is harvested prior to February 1.

5 Trip limit is reduced to 500 pounds/day when 75% of the subzone's quota is harvested.

6 3,500-pound trip limit begins March 1.

Beginning December 1, unlimited on Monday through Friday and not to exceed 1,500 pounds on Saturday and Sunday.

After 75% of the adjusted quota is harvested, the trip limit is 1,500 pounds. If 100 percent of the adjusted quota is harvested, the trip limit is reduced to 500 pounds.

7 Quotas are for commercial and recreational landings combined. Recreational landings are only available through June.
